

## **GO FETCH SERVICES**

### **Boarding & Daycare Waiver and Consent Agreement**

This agreement applies to all services provided by Go Fetch Services (“GFS”). By submitting an enrollment form and utilizing our facility, you agree to the following terms and conditions.

---

#### **1. Ownership and Authorization**

I represent that I am the legal owner of the dog(s) listed on the enrollment form, or I am authorized by the legal owner to enroll the dog(s) in services at Go Fetch Services.

---

#### **2. Health and Vaccination Requirements**

I certify that my dog(s):

- Are in good general health
- Are current on required vaccinations, including Rabies, Distemper, and Bordetella
- Are free of fleas, ticks, and lice
- Have not shown signs of illness within the past 30 days

I understand that while vaccinations significantly reduce the risk of contagious illness, no environment involving dogs can eliminate all risk. I accept full financial responsibility for any veterinary care required if my dog becomes ill.

#### **3. Collar and Equipment Policy**

All dogs must wear a properly fitted flat collar while at GFS. Metal chain collars, prong collars, and training collars are not permitted.

---

#### **4. Acknowledgment of Risk**

I understand that Go Fetch Services operates an open group play model. Dogs interact freely in a supervised environment. Although staff members monitor all playgroups, minor injuries such as scratches, scrapes, bumps, or sprains may occur.

I voluntarily accept the inherent risks associated with supervised group play and physical activity.

---

## **5. Temperament and Behavior**

I represent that my dog has not exhibited aggressive or threatening behavior toward people or other dogs.

GFS reserves the right, at its sole discretion, to remove any dog from group play if behavior is deemed unsafe, disruptive, or inappropriate. If necessary, a dog may be separated or dismissed from services for the safety of the group.

## **6. Breed and Participation Policy**

Go Fetch Services operates a structured, open group play environment. Not all breeds or individual dogs are suited for this setting.

Due to the physical strength, historical breed traits, and elevated injury risk associated with certain guarding and fighting breeds, GFS does not accept pit bull-type dogs, Staffordshire terriers, Cane Corsos, Akitas, Chows, or similar mixes.

This policy is based on over two decades of hands-on operational experience and our commitment to maintaining a safe and balanced environment for all dogs in our care.

We understand that opinions may vary, but safety remains our highest priority.

---

## **7. Veterinary Care Authorization**

In the event of illness or injury requiring medical attention, I authorize Go Fetch Services to contact my veterinarian or seek treatment at the nearest available veterinary facility.

I understand that I am financially responsible for all medical expenses incurred on behalf of my dog.

---

## **8. Late Pick-Up and Extended Stay**

If I or my authorized contact fail to retrieve my dog at the scheduled time, I authorize GFS to provide additional daycare or overnight services as necessary at my expense.

---

## **9. Boarding Policy**

Boarding is charged on an overnight calendar basis (not a 24-hour cycle). If a dog remains in our care past midnight, an overnight boarding charge applies.

On the final day of boarding, a daycare charge will apply regardless of the pickup time.

---

## **10. Holiday Policy**

During major holidays and holiday weekends (New Year's, Easter, Memorial Day, July 4th, Labor Day, Thanksgiving, and Christmas):

- A two-night minimum stay is required
  - A two-day deposit is required to reserve your dog's suite
  - Deposits are refundable if cancellation occurs at least seven (7) days prior to the scheduled drop-off date
  - GFS is closed for drop-offs and pick-ups on major holidays

## **Medical Release Authorization**

The safety and well-being of your pet is our highest priority.

In the event of a medical emergency, Go Fetch Services will seek immediate veterinary care at the nearest available facility to avoid delay in treatment. The owner will be notified as soon as arrangements have been made.

I authorize Go Fetch Services to obtain medical treatment for my pet if deemed necessary and agree to be financially responsible for all associated costs.
